

# REPAIR WARRANTY

US MICROJET LLC 6/13/2008

US MicroJet repairs are warranted against defects in material or workmanship for one hundred and eighty (180) days from the date of shipment from US MicroJet. This warranty does not cover normal wear and tear or FOD damage. This Warranty shall be null and void if the equipment is modified, improperly installed or used, any non-factory equipment is used, the turbine is damaged by accident or neglect, or in the event any parts are improperly installed or replaced by the user. If US MicroJet determines that the product returned to it for warranty service is not defective as herein defined, the customer shall pay all costs of handling and transportation.

For this warranty to be in effect the US MicroJet (or AMT USA) turbine must a) not have been serviced by anyone other than the US MicroJet factory and b) the owner has agreed to ALL RECOMMENDED SERVICE that US MicroJet deemed necessary at the time the turbine was repaired.

To the extent that it is determined that failure to follow the procedures listed in the US MicroJet Turbine Operations Manual shall have caused any defect in the turbine for which a warranty claim is made, this limited warranty shall be null and void and the customer shall be responsible for US MicroJet's current charges for labor and materials to repair said defect.

US MicroJet's sole obligation under this warranty shall be to furnish parts and labor for the repair or replacement of products found to be defective in material or workmanship during the warranty period.

As a condition of this warranty, the user must: (a) obtain a US MicroJet Return Authorization Number for the product); b) ship the product, transportation prepaid, to the authorized service location; (c) include with the product a written description of the claimed defect and a description of conditions and what occurred during the turbine's last usage; and d) include with the turbine all major components including the ECU and fuel pump. Products returned shall be packaged in the original packing and shipping container or comparable container. In the event the equipment is not so packaged or if shipping damage is evident, it will not be accepted for service under warranty. Surface transportation charges for the return of the product to the customer shall be paid by US MicroJet within the continental United States. Customer shall pay shipping costs, customs clearance, and other related charges outside this designated area.

The above warranties are in lieu of all other warranties, expressed or implied, oral or written, statutory or otherwise, including any implied warranty of merchantability or fitness for a particular purpose. No salesperson, representative or agent of US MicroJet is authorized to make any guarantee, warranty, or representation in addition to the foregoing warranty.

US MicroJet shall not, under any circumstances whatsoever, be liable to buyer or any other party for lost profits, diminution of good will or any other special or consequential damages whatsoever with respect to any claim hereunder. In addition, US MicroJet's liability for warranty claims shall not, in any event, exceed the invoice price of the product claimed defective, nor shall US MicroJet be liable for delays in replacement or repair of products. No waiver, alteration, addition, or modification of the foregoing warranties shall be valid unless made in writing and signed by an executive officer of US MicroJet LLC.
